VISITORS: Jeff Dondero, Chris Peed, Robin and Joan Cameron, St. Rep. Rodney Creech.

VISITOR COMMENTS: Mr. Dondero was here representing the Germantown Lions and the Twisted Pretzel Bike Tour that will go through Jackson Township on September 28 from 8-1:00 (approximately). There was an extended conversation regarding this bike tour and the negligence of the riders with obeying traffic laws. Chief Bruner stated that last year there was an individual parked at the corner and Elm and Hemple Rds. that stood in the road waving bikers on and not to stop. In addition, Mr. Moyer stated he witnessed bikers not even slowing down at the stop sign on South Elm. Chief Bruner said that bikers have the right to be on our road but he asked that the committee make sure they state very clearly that all motor vehicle laws are required to be followed in our area. In addition, Chief Bruner told Mr. Dondero that it is illegal for him to misrepresent an officer of the law and civilians are not permitted to stop or direct traffic. Mr. Dondero defended his hat/vest from last year saying it was not meant to mislead but Chief Bruner countered with "when you wear a hat with the letters OSP (Ohio State Patrol) and you are directing traffic it makes you look like an officer". Chief Bruner stated he wants the bike tour to be safe for all involved – including the vehicle drivers and bike riders. Ms. Cameron stated that they have frequently been on bike tours/iron man and notice bikers not obeying the rules. It was then decided that the Lions Club would make sure they announce and stress the importance that all traffic laws must be obeyed while participating in this event.

Rodney Creech stated later in the meeting he was there just to check in and make sure we were aware he is once again our State Representative and available for us any time. Our trustees acknowledged how pleased they are to have him back and look forward to having him to work with again.
